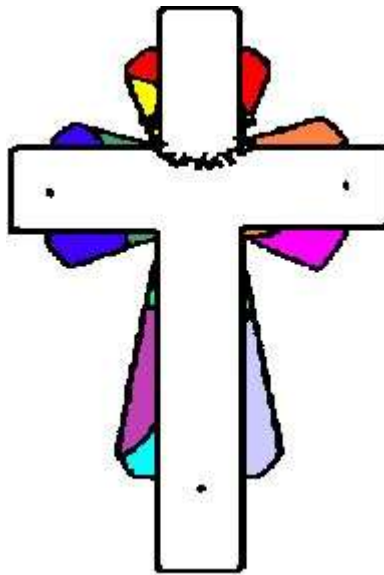




We continue to be thankful for you and your ministry, and we pray God's continued blessings upon you. May you have a blessed 2024!

2024 VIDA NUEVA AGREEMENT  
Between  
Vida Nueva International

The Local Community agrees to:

1. Be a Vida Nueva International community for the year 2024.
2. Conduct its programs and events in accordance with the Vida Nueva International materials described in Appendix A.
3. Refer to Vida Nueva International for any interpretation of the Vida Nueva International materials.
4. Seek prior written approval from Vida Nueva International before altering any Vida Nueva International materials.
5. Ensure that all members of its Board of Directors/Council/Steering Committee are active participants in a local church body.
6. Be in regular and prompt communication with Vida Nueva International regarding scheduled events, election of new officers, and other developments affecting the quality of the Local Community’s ministry.
7. Keep accurate accounting books and records, to preserve them for at least seven (7) years after they are generated or received by the Local Community, to have them inspected annually by someone other than the Local Community’s treasurer and to make the ensuing report available to any interested party as part of the Local Community’s corporate minute book.
8. Actively support emerging Vida Nueva communities through prayer, financial assistance, and team support. One of the known signs of a healthy Vida Nueva community is its involvement in growing new communities. The excitement that builds encourages community growth, not just in numbers, but also spiritual growth in God’s grace. As with church congregations, when people work to build ministries in new places, they are mobilized to increased participation in local activities as well.
9. Send some or all members of its governing body to All Community Meetings.
10. Have a unified working relationship with other Vida Nueva communities and with Vida Nueva International.
11. Renew this agreement on an annual basis unless this agreement is terminated by either party.
12. That it shall, at all times, follow instructions of Vida Nueva International with respect to the use of the Vida Nueva materials and trademarks.
13. Acknowledge that the Vida Nueva materials may, from time to time, be updated, amended and/or revised by Vida Nueva International and will endeavor to always use the most current material.
14. Honor the commitment to make a \$100.00 annual contribution to Vida Nueva International.
15. Conduct an annual review of the Essentials to involve all board members.
16. Accept financial, legal, and moral responsibility for all actions and decisions taken by your local Community. Permission slips should be retained for at least 3 years and background check data should be retained indefinitely.

Vida Nueva International agrees to:

1. Recognize the Local Community as a Vida Nueva Community.
2. Develop and support the Local Community in the fulfillment of the Vida Nueva vision and mission.
3. Commit to the upholding of the Local Community and this covenant in prayer.
4. Make available to the Local Community: Vida Nueva materials.
5. Provide training, guidance and consultation on the Vida Nueva vision and mission.
6. Provide direction and leadership for starting new Vida Nueva Communities (or re-starting dormant ones).
7. Provide resource persons and materials for leadership training and coordinate networking of the Vida Nueva communities.
8. Maintain regular communication with the leadership of the Local Communities.
9. Continually seek to improve Vida Nueva materials and programs.
10. Seek input and feedback from local communities as to how to best serve the individual communities.
11. Assist the local communities in their Essentials Review as requested.

The term of this agreement shall commence on the effective date and shall continue in effect until December 31, 2024, unless earlier terminated by Vida Nueva International or the Local Community. Further, Vida Nueva International shall have the right to terminate this agreement if the Local Community: a) breaches any of the terms of this agreement and fails to correct the breach within thirty (30) days following written notice.
