Emerging Community Agreement

This Emerging Community Agreement is a three-way agreement between:

- Vida Nueva International _____
- The Sponsoring Community _____
- The Emerging Community _____

The role of Vida Nueva International is to provide a liaison for oversight and guidance to the Sponsoring Community and the Emerging Community. The liaison will guide the involved communities to ensure the orderly growth of the Vida Nueva Movement and to ensure continued adherence to the key documents and spirit of the Vida Nueva Movement. VNI will endeavor to provide an observer for the Emerging Community’s first set of weekends to answer questions and provide guidance.

The role of the Sponsoring Community is to offer guidance, encouragement, and support to the leadership of the Emerging Community. This support is further described a document entitled “Responsibilities of a Sponsoring Community”.

The role of the Emerging Community is to build their new community on the principles provided under this agreement and the “key documents” of Vida Nueva International.

1. Whereas:

- 1.1 The name “Vida Nueva”, as it relates to three-day weekends, is the property of Mid-Hudson Vida Nueva. The Copyright of weekend materials developed for the “southern” model of Vida Nueva is held by Vida Nueva International.
- 1.2 The Sponsoring Community _____ is a chartered community in good standing with Vida Nueva international and agrees to encourage and support the new emerging Vida Nueva community.
- 1.3 The Emerging Community _____ agrees to build their new community on the principles provided under this agreement with the help of the Sponsoring Community under the oversight of Vida Nueva International.

Therefore: All three parties to this Agreement understand that for the Emerging Community to become a successfully chartered VN community, they must:

- Follow the “key documents” of Vida Nueva
- Have a Council which elects new officers every two to four years, on a rotational basis.
- Conduct separate weekends for young men and young women
- Conduct at least one set of weekends per calendar year

2. Agreement:

- 2.1 Vida Nueva International grants to the Emerging Community the right to use the Vida Nueva name and materials, and to conduct Vida Nueva Weekends within its location.
- 2.2 The Emerging Community and Sponsoring Community agree to follow the “key documents” of Vida Nueva for all activities and weekends of the newly emerging Community.
- 2.3 Vida Nueva International reserves the right to revoke this agreement if it is determined that the Emerging Community and/or the Sponsoring Community are not fulfilling their obligations under this agreement.
